

**INVITATION TO BID FOR DRILLING OF ONE (1)  
EXPLORATORY/PRODUCTION WELL AT  
BRGY. BUCAL, AMADEO, CAVITE**

1. The, *Amadeo Water District* through *LWUA - ICG Loan* intends to apply the sum of ***FOUR MILLION SIX HUNDRED SEVENTY ONE THOUSAND SIX HUNDRED NINETEEN PESOS AND NINETY SEVEN CENTAVOS (Php 4,671,619.97)*** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***DRILLING OF ONE (1) EXPLORATORY/PRODUCTION WELL AT BRGY. BUCAL, AMADEO, CAVITE.*** Bids received in excess of the ABC shall be automatically rejected at bid opening.
  2. The *Amadeo Water District* now invites bids for the ***DRILLING OF ONE (1) EXPLORATORY/PRODUCTION WELL AT BRGY. BUCAL, AMADEO, CAVITE.*** Delivery of the Goods is required within ***141 calendar days*** upon receipt of Notice to Proceed, as per delivery schedule in Section VI. Bidders should have completed, within ***five (5) years*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction of Bidders.
  3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the “Government Procurement Reform Act”.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the *Amadeo Water District* through the BAC Secretariat and inspect the Bidding Documents at the address given below ***during weekdays 8:00 AM to 5:00 PM.***
  5. A complete set of Bidding Documents may be acquired by interested Bidders on ***October 28, 2020 to November 18, 2020*** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ***Five Thousand Pesos (Php 5,000.00).***
  6. The *Amadeo Water District* through the Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on ***November 5, 2020, 1:30 PM at 012 J. dela Peña St., Brgy.***

***Poblacion 9, Amadeo, Cavite*** which shall be open only to interested parties who have purchased the Bidding Documents.

7. Bids must be duly received by the BAC Secretariat at the address below on before ***November 18, 2020, 1:00 PM***. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***November 18, 2020, 1:30 PM at Amadeo Water District, 012 J. dela Peña St., Brgy. Poblacion 9, Amadeo, Cavite***. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The ***Amadeo Water District*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
