

INVITATION TO BID

SUPPLY AND DELIVERY OF VARIOUS WATER SERVICE CONNECTION MATERIALS FOR FIRST AND SECOND QUARTER PROCUREMENT

1. The **AMADEO WATER DISTRICT**, through its **CY 2021 Corporate Budget Approved by the Governing Board** intends to apply the sum of **ONE MILLION SIX HUNDRED SIXTY ONE THOUSAND SIX HUNDRED THIRTY PESOS (PHP 1,661,630.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF VARIOUS WATER SERVICE CONNECTION MATERIALS FOR 1ST AND 2ND QUARTER PROCUREMENT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **AMADEO WATER DISTRICT** now invites bids for the **Supply and Delivery of Various Water Service Connection Materials for 1st and 2nd Quarter Procurement**. Delivery of the Goods is required within fifteen (15) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from **AMADEO WATER DISTRICT** through **BAC Secretariat** and inspect the Bidding Documents at the address given below during weekdays from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 7, 2021** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**.

6. The AMADEO WATER DISTRICT through the Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on **January 15, 2021, 10:00 AM** at Amadeo Water District, 012 J. dela Peña St., Brgy. 9, Amadeo, Cavite, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below **on or before January 28, 2021 at 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause **Error! Reference source not found.**

Bid opening shall be on **January 28, 2021, 10:10 AM** at AWD Board Room, 012 J. dela Peña St., Brgy. 9, Amadeo, Cavite. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. This procurement will be subject to **Ordering Agreement** arrangement pursuant to the issued Guidelines on the Use of an Ordering Agreement under the Government Procurement Reform Act.

The **AMADEO WATER DISTRICT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
